## **NFAS PROPOSALS 2017**

The time has come again for you to put forward any changes you believe need to be made to NFAS rules. Any proposals put forward will be published in the next newsletter, along with the proposer's rationale of the benefits it will bring. This gives you a chance to talk through any proposals with your fellow archers ahead of voting.

Every proposal submitted (except a change in the Constitution) needs the support of five members eligible to vote - the proposer and four others. Any new rule (or proposed amendment to an existing rule) needs to be clear and unambiguous. Where a proposal is so vague that the Committee believes that the wording being proposed is not a clear rule and will cause significant problems, we will go back to the proposer to talk through the drafting.

On the following page is a form to complete if you want to put forward a proposal. All the sections must be completed for the form to be valid. At the Annual General Meeting in November there will be an opportunity to debate and suggest possible improvements to each proposal. The proposer or one of his/her named supporters must be at the AGM to explain the benefits the proposal might bring to the Society (otherwise the proposal will be rejected automatically). The proposer has the right to accept or reject any suggestions for amending the proposal.

The venue for the AGM will be announced in the next newsletter. Following the AGM, the proposals with any amendments, will also be published in the next newsletter along with a voting slip and details of web-based voting. Those eligible to vote are full adult members and life-time members. The results will then be published in the subsequent newsletter and any changes will come into effect on 1st April 2018.

If you wish to propose a change to the Constitution this requires 50 signatures to be collected because the intention is that the Constitution should not be chopped and changed unless there is a significant reason and support to do so. Anyone wishing to put a proposal forward for the AGM, please make sure that they read the proposal form correctly and complete all sections in accordance with the constitution/shooting rules etc (depending on the proposal).
