

The forms to change, remove or add an NFAS rule is included in this edition of the magazine. All sections must be completed for the form to be valid. Here are some guidelines to ensure a smooth process:

- ⚠️ Proposals will need to be submitted by five members eligible to vote - the proposer and four others. Changes to the Constitution require signatures from 50 members entitled to attend and vote.
- ⚠️ Proposals will need to be clear and unambiguous. Any queries by the Committee will be discussed with the proposer to ensure the meaning of the proposal is clear and not cause undue confusion.
- ⚠️ Proposals will be published in the November/December magazine to give the members a chance to discuss the changes with other archers ahead of the discussion at the AGM.
- ⚠️ The proposer or one of the supporters must attend the AGM to explain the benefits of the proposal. This gives members the opportunity to debate and suggest possible improvements to each proposal. The proposer has the right to accept or reject any suggestions for amending the proposal. If no supporters nor the proposer attend the meeting, then the proposal will automatically be rejected.
- ⚠️ Following the AGM, the proposals, with any amendments, will be published in the January/February 2026 magazine along with voting forms and implementation will be 1st April 2026.
- ⚠️ Online entries will be accepted however they must be signed and written correctly. Any postal entries received after the deadline will not be accepted. Proof of posting will not be accepted.

The date of the AGM is, **Sunday 26th November 2025** and will be held:
